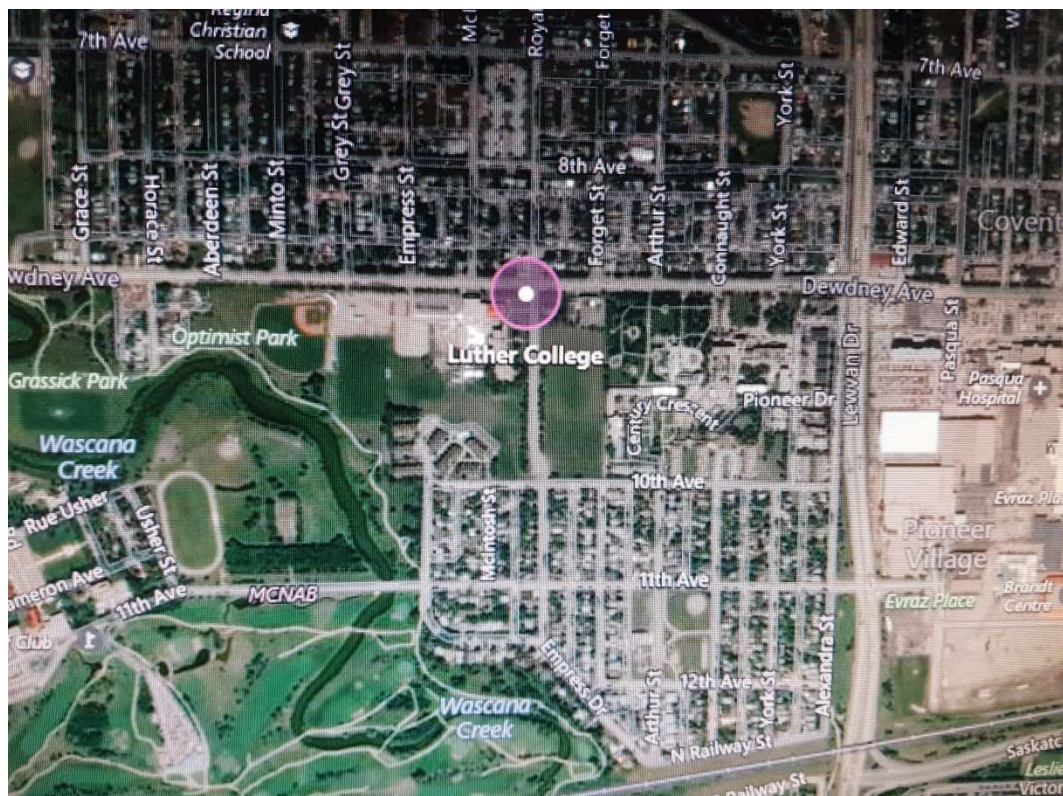

Competition Rules

Patterns (Single Elimination)

- 2 Competitors elimination system will be used for all **Coloured Belt** divisions
- 2 Competitors elimination system will be used for all **Black Belt** divisions

Sparring (Double Elimination)

- One round of 1½ minutes continuous sparring will be in effect for all **Coloured Belt** divisions
- No overtimes for **Coloured Belt** divisions. In the event of a tie, the competitor with less warnings will determine the winner.
- There will be one round of 2 minutes for black belts eliminations. Finals will be two (2) rounds at 2 minutes each round (**Black Belts**)
- In the event of a tie (**Black Belts**), there will be an additional one (1) minute round, and after is sudden death (first to score wins).
- Point system for sparring will be as follows:
 - Punch/hand technique to the head or body (on ground) = 1 point
 - Kick to the body (on ground) = 1 point
 - Jumping punch/hand technique (off ground) to the head= 2 points
 - Jumping kick to the body = 2 points
 - Jumping kick to the head = 3 points

Warnings, Fouls and Disqualifications (Free Sparring)

1. Warnings may be issued for the following reasons:

- Stepping completely out of the ring
- Falling down (whether intentional or not)
- Faking an injury
- Intentionally avoiding sparring (i.e. running away, using Centre Referee as shield)
- Any unintentional attack to an illegal target (i.e. both above or below the belt)
- Pushing with hands, shoulders or body



Competition Rules

2. Fouls may be issued for the following reasons:

- Excessive heavy contact
- Attacking a fallen opponent
- Leg sweeping
- Holding or grabbing
- Intentional attack to an illegal target (targeting or contact to any prohibited target both above or below the belt)
- Unsportsmanlike conduct (any action by competitor showing disrespect, lack of following directions or unacceptable behavior towards referee and opponents or other officials)

3. Disqualifications may be issued for the following reasons:

- Misconduct against officials or ignoring instructions
- Uncontrolled or excessive contact
- Receiving three (3) minus points/fouls given by referee
- Being under the influence of alcohol or drugs
- Loss of temper
- Insulting an opponent, coach and/or official
- Biting/scratching
- Attacking with knee, elbow or forehead
- Being negatively responsible for causing loss of consciousness



Competition Rules

Uniforms (Athletes)/Attire (Judges)

- All athletes that will be competing in this tournament must be in **proper uniforms**. As this is an Open Taekwon-Do Championship, all styles of uniforms will be accepted.
 - *****Please note, however, that t-shirts worn together with uniform pants will not be acceptable nor allowed at this championship. *****
- All judges volunteering at the tournament must wear proper attire consisting of a dark dress pants (i.e. black or navy), tournament judging shirt, white shirt, black shoes or white running shoes.

Sparring Equipment

All competitors must have the following **mandatory gear** to compete in the Sparring division:

- Foot (* toes must be fully covered and not exposed *)
- Hand (* fingers must be fully covered and not exposed *)
- Head Gear (optional for adult black belts)
- Mouth Piece
- Groin Cup (Males)

Coaches

Only registered coaches will be allowed on the competition floor. There will be absolutely no exceptions to this rule. Coaches can be a Master, Instructor or a registered Black Belt and must be at least 16 years of age. Coaches are reminded to bring their own towels. *** ***Water bottles, spray bottles and ice spray.******

All registered coaches must be in a tracksuit for Black Belt competition. **Doboks are not allowed**
